Business Purpose

The purpose of this report is to provide the cumulative net income or loss generated by the operation of the fund since its inception (ending balance) and the amount of expendable and available financial resources (available fund balance). This report is grouped by division, campus and department. The report provides the beginning fund balance which is the money the fund started with on September 1st. It is the previous fiscal year's unspent funds that carried forward. It then provides the total of the revenue, expenses, and transfers in the current fiscal year. The ending fund balance then subtracts the fund's encumbrances and reserves as well as the salary reserves to provide the available fund balance. The available fund balance is the portion of the fund's balance that reflects expendable and available financial resources.

This report is independent of the budget process. This report reflects the true money owned by the fund regardless of how much of that money has been budgeted.
