# **Business Purpose**

The purpose of this report is to provide the cumulative net income or loss generated by the operation of the fund since its inception (ending balance). This report is sectioned by division, campus, and department and grouped by fund category and fund class. The report provides the beginning fund balance which is the money the fund started with on September 1<sup>st</sup>. It is the previous fiscal year's unspent funds that carried forward. It then



provides the total of the revenue, expenses, and transfers in the current fiscal year. The ending fund balance is the portion of the fund's balance that reflects expendable and available financial resources but does not take current encumbrances and reserves into account.

This report is independent of the budget process. This report reflects the true money owned by the fund regardless of how much of that money has been budgeted.
