#### **Our Mission**

Texas Tech University Health Sciences Center, where a dedication to education, patient care and research has made an impact on the health of West Texas and beyond for almost 40 years. #### **HUB Program**

The Historically Underutilized Business (HUB) program is a state of Texas initiative to increase the opportunities available to businesses owned by minorities and women in the area of state procurement and contracting. A HUB is a sole proprietor, partnership, or corporation in which at least 51% of the stock or other equitable securities are owned by one or more persons who are members of the following groups: Asian Pacific Americans, Black Americans, Hispanic Americans, Native Americans, and women. These individuals must have a proportionate interest in the control, operation, and management of the business, as well as, their principal place of business must be located in Texas.

The Texas Tech University Health Sciences Center HUB office ensures the agency's good faith effort to include HUB businesses in its procurement efforts. This good faith effort involves evaluating and determining HUB subcontracting opportunities, administration of the agency Mentor /Protégé program, participating in marketing and outreach efforts for HUB participation, and HUB reporting to the Texas State Comptroller.

### **How to Certify**

- HUB Certification through the Statewide HUB Program requires general information about your business and supporting documentation to substantiate business structure and HUB eligibility.
- Your file will be entered into the State database and assigned to a certification specialists.
- The certification specialist will review your file for completeness and HUB eligibility criteria. If more information is needed, the certification specialist will request this information from the primary point of contact listed on your application.
- Upon certification approval, your vendor profile will be uploaded into the <u>HUB Directory</u>.
   A HUB certification package, which includes a certificate and resources for doing business with the state, will be mailed to the address provided on your application.

#### **Important**

It is vital to be truthful in all documents provided for HUB certification. It is a state jail felony under <u>Texas Penal Code §37.10</u> to knowingly provide false information in an application for HUB certification. It is a third degree felony under <u>Texas Government Code §2161.231</u> to apply for a state contract as a HUB vendor knowing you are not actually a HUB.

#### **CMBL**



#### **Registering Your Business**

TTUHSC additionally utilizes the State of Texas Certified Master Bidders Listing (CMBL) to notify vendors of formal solicitations and the Electronic State Business Daily (ESBD) for public announcements.

We strongly suggest that an active, accurate and current email address be maintained on your company's CMBL profile to insure receipt of bid opportunities.

**Please note:** The CMBL annual registration fee is \$70.00.

#### **Benefits of HUB Certification**



#### Benefits Include:

HUB certification is free of charge.

Certification is valid for 4 years, provided that business continues to meet the eligibility requirements.

Business is registered on the Comptroller's Web-based <u>HUB Directory</u>. State agencies use the HUB Directory in conjunction with the Comptroller's <u>Centralized Master Bidders List (CMBL)</u> to solicit bids from certified HUBs for state purchasing and public works contracts. Prime contractors also use the HUB Directory to identify HUBs to whom they will send notification of their subcontracting opportunities.

Increased exposure to the general public, as well as, other entities who have a supplier diversity program and are searching for minority and woman-owned businesses.

\* Vendors may also receive HUB certification by way of a certification memorandum of agreement the Statewide HUB Program has entered into with other local governments or nonprofit organizations.
