Budget Revision System User Guide

Purpose

The Budget is a means to set departmental priorities and control spending. During the course of a fiscal year it may be necessary to adjust an existing budget or establish a budget on a new FOP. This will be done using the Budget Revision System (BRS).

Features

- **Available Balance and Current Budget Display**
The BRS displays the current amount budgeted on the FOAP line. It also displays the budget available balance (BAVL) that may be adjusted.
- **Automated Editing**
The BRS edits each FOAP line for accuracy. This helps alleviate data entry errors.
- **Document is Automatically Saved**
The BRS saves the document after each section of the BRS has been completed. This allows the user to work on a document and retrieve it for completion at a later time.
- **Automated Routing**
The system establishes the appropriate routing for each budget revision, and upon submission alerts approvers of documents requiring their approval.
- **Uploads to Banner Finance**
Approved documents are uploaded to the Banner Finance system every 15 minutes throughout the work day.
- **Allows for Comments and Attachments**
The BRS has a place for comments to be added, and a place to upload supporting documentation for a budget revision. Approvers are able to view the comments and attachments. Approvers may also add their own comments and upload attachments.
- **Tracking and History**
The BRS is the storage location for all processed budget revisions. Users may log into the system and view documents previously processed or track revisions through the approval process.
- **Notification upon Approval**
The system notifies the budget revision originator when the budget revision document has been approved and posted to the Banner Finance system.

Preparation

Required Information

- **FOP**

The FOP (Fund, Organization, Program) is required on all budget revision documents. There are a variety of Finance and Budget Cognos reports containing FOP information and the available balance in each FOP. Below is a list of three reports that provide this information:

- *HSC Finance>Finances Relative to Budget >Budget Account Code Summary*
- *Budget>Budget Financial Reports>RPT_BAVL_005 – Available Balance by Organization (BAVL)*
- *Budget>Budget Financial Reports>RPT_OPAL_005 – Operating Ledger*

If funds are being transferred to or from another FOP, the opposing FOP information is required as well.

- **Budget Account Code**

Only the four digit Budget Account Codes may be used in the BRS. The following Cognos reports are available to determine the appropriate Budget Account Code:

- *Budget>Budget Financial Reports>RPT_ACCT_001 – Budget and Data Entry Account Codes*
- *Budget>Budget Financial Reports>RPT_ACCT_002 – Data Entry Account Codes and Budget Account Codes*

- **Type of Revision to be Completed**

Four Budget Revision Options are available within BRS. It is important to understand the differences between each option and to select the action that reflects the type of budgetary change being requested.

- **Option 1: Adjust Budget within Fund** – this option is used to move budget between salary or expense codes within the same fund. In some circumstances it can also be used to move between transfer codes. Contact the Budget Office if a transfer code should be used on an Option 1 revision.

Examples:

- 1) Department needs to move funds from 7010 into code 6005 to cover a shortfall in longevity.
- 2) Department needs to move funds from 7099 into code 6008 to cover anticipated overtime.
- 3) Department needs to move funds from 7020 to 7021 for out of state travel.

- **Option 2: Budget of Fund Balance** – this option is used to budget funds into the current fiscal year from prior year fund balance.
Examples:
 - 1) Department needs to budget funds from fund balance for new faculty start up.
 - 2) Department has an IDC fund (Indirect Cost) with a prior year fund balance they would like to budget for an equipment purchase.
- **Option 3: Budget of Revenue** – this option is used to increase a revenue budget. The department must verify that the current revenue budget will be exceeded before budgeting an increase in revenue.
Examples:
 - 1) Department receives a new grant fund. The Option 3 revision is used to budget the grant award revenue and approved expenditures.
 - 2) Department's current revenue budget is \$50,000, but earned revenue is \$58,000. The Option 3 revision is used to budget the over recognized revenue of \$8,000 and to increase the expense budget.
- **Option 4: Transfer between FOPs** – this option is used to transfer money between two funds.
Examples:
 - 1) Department is establishing a new cost sharing fund that is funded from an existing fund.
 - 2) The fund related to year 1 of a grant must be closed and the remaining balance transferred to the year 2 fund number.
 - 3) Per an agreement, department A transfers funds to department B.
 - 4)

Tips for Using the System

- Check the Errors/Warnings panel if problems exist when submitting a revision. See Appendix B for a list of errors and warnings and the possible causes.
- Ensure the correct Budget Revision Option is selected.
- Be familiar with departmental FOPs and budget account codes.
- Run suggested reports to verify funds are available to reallocate.

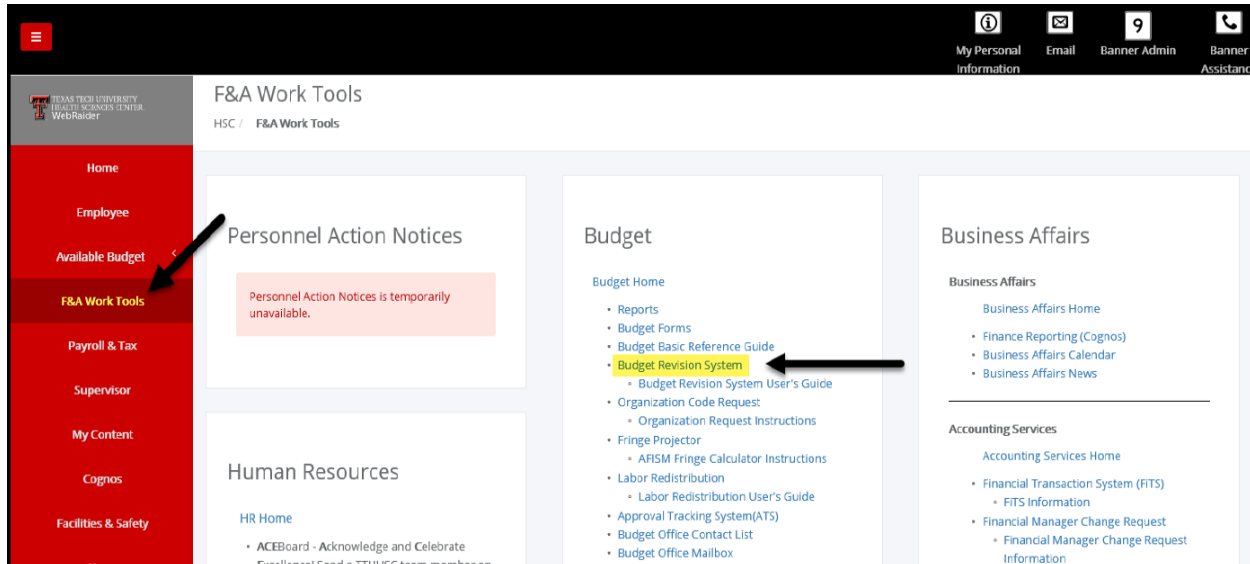

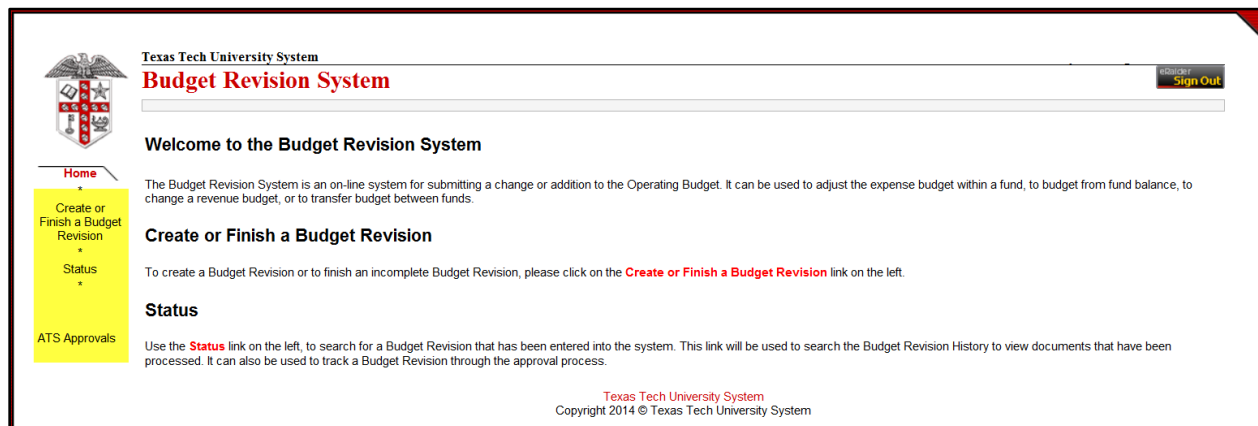
Webraider Portal

Three links appear on the left side of the Welcome Screen (highlighted in the screen shot above):

- 1) Create a Budget Revision – this link is used to start a new budget revision or finish an incomplete revision.

- 2) Status – this link is used to track a budget revision through the approval process, or view a document that has already been processed.
- 3) ATS Approvals –this link is used to access the Approval Tracking System for those who approve budget revisions. (Thus the link may not be present for all users.)

The User Information section infers employee information from the Human Resources System within Banner. This information cannot be changed in BRS; however the radio button 'Change Alternate Contact' option is available to provide a more accurate phone number for the user. This information is important in the event the Budget Office has questions regarding the revision.

Input the correct or alternate phone number and click the radio button save. After saving, this section may be hidden by clicking the radio button hide. This will only need to be done one time. BRS saves the alternate phone number and will display it on future revisions.

Errors/Warnings Panel

Most errors and warnings will be located in the Errors/Warnings Panel located in the top right portion of BRS. Check this panel for an error message if an issue exists when submitting a budget revision. See Appendix B for a list of errors and warnings and their possible causes.

- **Chart Code:** Select the Finance Chart of Accounts for this revision.
 - H - Texas Tech University Health Sciences Center
 - T - Texas Tech University
 - S - Texas Tech System
 - E- Texas Tech University Health Sciences Center at El Paso
- **Perm/Temp:** This field will default to Temporary.
 - Permanent – Choose this selection if the budget change should be reflected in the next budget prep cycle.
 - Temporary – This selection is used if the budget change only affects the current fiscal year budget.
- **Budget Revision Type:** This determines how BRS will populate the next sections.
 - Option 1: Adjust Budget within Fund – this option is used to move Budget between expense account codes within the same fund.
 - Option 2: Budget of Fund Balance – this option is used to budget funds into the current fiscal year from prior year fund balance.
 - Option 3: Budget of Revenue – this option is used to increase a revenue budget. The department must verify that the current revenue budget will be exceeded before budgeting an increase in revenue.
 - Option 4: Transfer between FOPs – this option is used to transfer money between two funds.

Optional or Informational Fields:

- **Fiscal Year:** Populates with the current fiscal year.
- **Validation Date:** Populates with today's date and is used to validate against Banner Finance.

- **'Change FY' radio button** allows the fiscal year to be changed. The fiscal year will always default to the current fiscal year based on the date the budget revision is initiated. The only time the fiscal year may need to be changed is in late August or early September when two fiscal years are open for processing in the Banner Finance system. Contact the Budget Office if the fiscal year should be something other than the default for a budget revision.
- **Budget Revision Transaction:** After each field of this section has been completed, the system will assign a Budget Revision Transaction number. This number can be used to track the budget revision through the approval process and will be displayed on the automated emails to each approver and to the originator when the revision is approved or rejected.
- **'Delete' radio button** can be used any time prior to submission to completely delete this budget revision transaction. This button will remove the budget revision transaction from the system entirely.

Required data enterable fields:

- **Fund:** Enter the six digit fund number that will be adjusted by this budget revision. Click the 'Next' radio button or the keyboard enter key. The fund title will automatically populate.

- **Click the 'Change Fund' radio button** if the fund entered is incorrect. The Fund field will open up and allow for changes to be made.

Optional or Informational Fields:

- **Grant Code:** The grant code and grant title will populate if the fund entered is a grant.
- **Grant Begin/Grant End:** The grant begin and end dates will populate if the fund entered is a grant.
- **Grant PI:** The grant PI (Principal Investigator) name will populate if the fund entered is a grant.
- **Agency Name:** The granting agency name will populate if the fund entered is a grant.

Expense Acct Entry

The Expense Acct Entry section is used to adjust the Expense Budgets for Options 1, 2 & 3. Below is an example of the Expense Acct Entry section. Here is an example of a completed and balanced Expense Account Entry section. Two expense account lines have been added to this budget revision.

Required data enterable fields:

- **ORGN Code:** The organization code is populated based on the default organization code. If no default exists, enter a valid organization code. If a default organization code

is populated it may be changed by clearing the field and entering a valid organization code. Most grant funds use the default organization code.

- **Program Code:** The default program code for the fund is populated. This program code can only be changed if the default program code is 10, 35 or 40. To change the program code, clear the field and enter the correct program code (10, 35 or 40). Contact the Budget Office for questions related to default program codes.
- **Account Code:** Input the four digit Budget Account code to be adjusted. The Expense Acct Entry section will only allow expense or transfer account codes (account codes beginning with a 6, 7 or 8). After inputting the Budget Account code hit the tab key to advance to the Amount field.
- **Amount:** Enter the amount that this FOAP line needs to be adjusted.
- **Plus/Minus:** Select to increase or decrease the account code.
- **'Add' radio button:** will add this line to the Budget Revision document.

Optional or Informational Fields:

- **Default Organization:** If the fund has a default organization code it is displayed here.
- **Default Program:** The default program code for the fund is displayed.
- **Document Total:** This field keeps a running total of the Option 1 document. When the document total is 0.00, the document is balanced and can be submitted.
- **Fund Code:** The fund code is displayed based on the fund entered in the Fund Entry section.
- **Orgn Code Description:** The organization code title is populated after tabbing to the next open field. If 'ORGN Invalid' appears in this field, the orgn code has been incorrectly entered. Correct the orgn code before continuing.
- **Account Code Description:** The account code title is populated after the account code is entered and the tab key is clicked. If 'Not a valid ACCT code' appears, the account code has been incorrectly entered. Please verify the account code and reenter it.
- **Current Budget Amount:** The current budget amount will populate for the FOAP information entered. This is the actual amount currently budgeted for this FOAP. The amount displayed is accurate in the Banner Finance system as of the time the FOAP fields are entered. It is not from the night before and may not match Cognos reports if an entry has been posted to the system during the day.

The Budget Revision system will NOT allow the budget for this FOAP to be reduced by an amount greater than the Current Budget Amount. A FOAP budget balance cannot be

negative. Budgets for Transfers In maintain a negative balance. The Current Budget Amount for Transfers In may not exceed zero.

- **Budget Available Balance:** This is the BAVL balance for the FOAP. Please see the “Budget Basics” document at https://hscweb.ttuhs.edu/budget/instructions_and_information.aspx for more information on how budget controls affect the BAVL balance. The BAVL balance is also a real time number from the Banner Finance system and may not match Cognos reports if entries have already posted for the day.

The Budget Revision system will NOT allow the budget on a FOAP to be reduced by an amount greater than the BAVL balance.

- **‘Clear’ radio button:** clears the data entered in this budget line.
- **‘Edit’ radio button:** opens up this line for changes.

Adding an Expense Budget Line

- 1) Input date into each required field listed above.
- 2) Use the tab key to advance to the next field. This will populate the information fields with data.
 - a. If the tab key does not allow you to go forward, it may indicate that an invalid organization, program or account code has been entered.
- 3) Click ‘Add’ radio button to add the line.
- 4) Repeat the above steps to add another expense budget line.
- 5) When all lines have been added, check the ‘Document Total’ box and verify that your budget revision is balanced. A balanced budget will have a Document Total = 0.00.
- 6) Errors may prevent an expense account entry line from being added. Review the error messages in the error panel. Appendix B provides an explanation of the error message and suggested ways to clear the error message.

Editing/Deleting an Expense Budget Line

The ‘Edit’ radio button can be used to open all data entry fields to make changes to a previously added line. Click the ‘Edit’ radio button next to the line with the error.

- 1) Use the mouse to click into the field to be changed.
- 2) Clear the field and input the correct value.
- 3) Click the ‘Save’ radio button to save your change.

- 4) If you clicked the 'Edit' radio button in error, simply click the 'Cancel' radio button to cancel the edit feature.
- 5) If you need to remove the entire expense budget line, use the 'Delete' radio button.

Option 1: Adjust Budget within Fund

Using Option 1

Option 1 is used to move budget between salary or expense codes within one fund. In some circumstances it can also be used to move budget into or out of a transfer code. Contact the Budget Office before using Option 1 to adjust a transfer code.

This option is not only used to move budget between codes within the same fund, but is also used to move budget between different organization or program codes within the same fund. For example, a department might have all 6008 (other employee payment) funds budgeted in program code 35. If some of this budget should be moved to program code 40, Option 1 would be used.

Option 1 Entry

An Option 1 revision is entered by completing the Fund Entry section and the Expense Account Entry section as noted in the Basics for Option 1, 2 and 3 above.

After all expense account lines have been entered, the following should be verified.

- 1) Ensure the document total field equals 0.00. This means the revision is balanced. All budget revisions must be balanced before submission.
- 2) Check any warning messages to ensure the budget revision is valid. See Appendix B for a list of warnings and their possible causes.
- 3) Make note of the Budget Revision Transaction Number in the Create a New Budget Revision section in order to track the budget revision upon submission, or to complete the revision at a later time.

The following Option 1 revision is balanced and ready for the next step.

Option 2: Budget of Fund Balance

Using Option 2

Option 2 is used to budget funds into the current fiscal year from prior year fund balance. Fund balance may be used for one-time expenditures such as capital or faculty startup. Justification for the budget of fund balance must be included in the Comments section of the Budget Revision system. Budgeting of fund balance is only allowed on the following fund types:

- Designated
- Auxiliary
- Restricted Fiscal Year (non MY)

The amount of unbudgeted prior year fund balance is displayed in the Available Balance field. The BRS limits the budget revision to this amount. The complete calculation of this amount is available on Cognos report *Budget>Budget Financial Reports>RPT_GENL_001 – Prior Year Fund Balance Available to Carry-Forward*.

Option 2 Difference

The Option 2 revision is a self-balancing budget revision. The BRS will automatically balance any expense acct budget lines with a new section titled Fund Balance Information.

Before entry the Option 2 revision looks like the screen shot below. The additional Fund Balance Information section appears above the Expense Acct Entry section.

Optional or Informational Fields:

- **Document Total:** The Option 2 revision is self-balancing. This document total will always be 0.00.
- **Fund Code:** The fund code will populate based on the fund entered in the Fund Entry section.
- **ORGN Code:** The organization code is defaulted based on the organization code entered into the Expense Acct Entry section of the revision. If multiple organization codes are used in the Expense Acct Entry section, multiple fund balance lines will be added.
- **Orgn Code Description:** This is the organization code title of the ORGN code listed.
- **Account Code:** The account code defaults to the fund balance Budget Account Code of 5099.
- **Account Code Description:** The account code title is displayed to describe the Account Code listed.
- **Current Budget Amount:** The current budget amount will populate for the FOAP displayed. This is the actual amount currently budgeted for this FOAP. The amount displayed is accurate in the Banner Finance system as of the time the FOAP fields are entered. It is not from the night before and may not match Cognos reports if an entry has been posted to the system during the day.
- **Available Fund Balance:** The available fund balance is calculated as follows.

- *Prior Year Ending Fund Balance – Prior Year Encumbrances – Current Fund Balance Budget*

The available fund balance is not the cash balance in the fund on a given day. Instead it is a balance of what is left over from the prior fiscal year minus any 5099 fund balance amount budgeted in the current fiscal year for the entire fund.

- **Amount:** The amount is a summation of the amounts entered in the Expense Acct Entry section.
- **Plus/Minus:** System populated based on the overall increases or decreases entered in the Expense Acct Entry section.

Option 2 Entry

An Option 2 revision is entered by completing the Fund Entry section and the Expense Acct Entry section as described in the Basics for Options 1, 2 and 3 section of this document.

In the example below, the amount of fund balance being budgeted corresponds to the amount budgeted in Capital Outlay. The other 2 lines are general movement between expense codes. The justification for this use of fund balance will be entered in the Comments section of the Budget Revision system.

- 1) Check any errors and warning messages to ensure the budget revision is valid. See Appendix B for a list of errors and warnings and their possible causes.
- 2) Make note of the Budget Revision Transaction Number in the Create a New Budget Revision section in order to track the budget revision upon submission, or to complete the revision at a later time.

Option 3: Budget of Revenue

Using Option 3

The Option 3 revision is used to increase the revenue budget. Typical uses of the Option 3 revision are to increase the revenue budget due to a new grant award or to increase a budget if a new contract is received.

When revenue budgets are increased on an existing fund, it is important to verify that the fund will actually receive all revenue currently budgeted as well as the proposed increase to the revenue budget.

Option 3 Difference

The Option 3 revision contains two new sections: The Revenue Acct Entry section and the Revenue Analysis section.

Revenue Acct Entry

The Revenue Acct Entry section is used to input the revenue code and the amount of the revenue adjustment.

Required data enterable fields:

- **ORGN Code:** The organization code will populate based on the default organization code. If no default exists, enter a valid organization code. If a default organization code is populated it may be changed by clearing the field and entering a valid organization code. Most grant funds use the default organization code.
- **Program Code:** The default program code for the fund is populated. This program code can only be changed if the default program code is 10, 35 or 40. To change the program

code, clear the field and enter the correct program code (10, 35 or 40). Contact the Budget Office if the default program code appears to be incorrect.

- **Account Code:** Input the four digit Budget Account code that needs to be adjusted. Only revenue account codes can be entered in this section (account codes beginning with a 5). After inputting the Budget Account code hit the tab key to advance to the Amount field.
- **Amount:** Data enter the amount that this FOAP line needs to be adjusted.
- **Plus/Minus:** Select to increase or decrease the account code.
- **Click:** the 'Add' radio button to add this line to the Budget Revision document.

Optional or Informational Fields:

- **Default Organization:** If the fund is associated with a default organization code it will be populated here.
- **Default Program:** The default program code for the fund will be populated.
- **Document Total:** This field is a total of all Revenue Acct Entry lines minus all Expense Acct entry lines (*Revenue – Expenses*). The document total must be 0.00 for a balanced budget revision. The revision cannot be submitted until the document total contains a 0.00 balance.
- **Fund Code:** The fund code is displayed based on the fund entered in the Fund Entry section.
- **Orgn Code Description:** The organization code title is populated after tabbing to the next open field. If 'ORGN invalid' appears in this field, the organization code has been incorrectly entered. Correct the orgn code before continuing.
- **Account Code Description:** The account code title is populated after the account code is entered and the tab key is clicked. If 'Not a valid ACCT code' appears in this field, the account code has been incorrectly entered. Correct the account code before continuing.
- **Current Budget Amount:** The current budget amount will populate for the FOAP information entered. This is the actual amount currently budgeted for this FOAP. The amount displayed is accurate in the Banner Finance system as of the time the FOAP fields are entered. It is not from the night before and may not match Cognos reports if an entry has been posted to the system during the day.

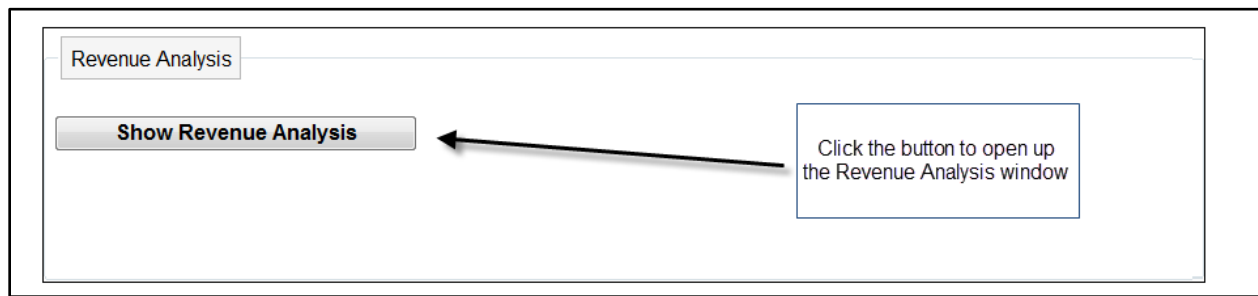
The Budget Revision system will NOT allow you to reduce the budget for this FOAP in an amount greater than the Current Budget Amount. A FOAP budget balance cannot be negative.

- **YTD Revenue Received:** This is the actual year to date revenue received on this FOAP line. The amount comes from the Banner Finance system at the time the FOAP fields are entered. It is not from the night before and may not match Cognos reports if an entry has been posted to the system during the day.
- **'Clear' radio button:** will clear the data entered in this budget line.
- **'Edit' radio button:** will open this line for changes.

Revenue Analysis

The Revenue Analysis section is informational only. This section displays annualized revenue totals for the current year and actual revenue totals for two previous fiscal years. This section is to be used to assist in determining if the revenue budget for the fund has already been earned and if an increase to the revenue budget can be supported.

Click on the 'Show Revenue Analysis' radio button to open up the Revenue Analysis window.

Informational Fields:

- **'Hide Revenue Analysis':** radio button will close the Revenue Analysis window.
- **Fund:** The fund used in the budget revision will be displayed. All numbers in this window are for this fund.

- **Annualized/Actual Revenue:** The actual revenue earned for this fund for the prior two fiscal years is displayed. The current year displays a straight lined annualized revenue calculation (actual revenue as of the close of the previous accounting period divided by the # of closed periods multiplied by 12).

Example:

- Actual YTD revenue as of close of period 03 = \$2,998.84
 - Number of closed accounting periods = 3
 - Annualized revenue = \$11,995.36 $((\$2,998.84 / 3) * 12)$
- **Total Revenue Budget:** The revenue budget for the entire fund (excluding fund balance) will be displayed for the current and prior 2 fiscal years.
- **Difference:** This is a calculated field reflecting the difference in the annualized/actual revenue minus the revenue budget.
- **Grant Inception to Date:** The grant inception to date column will appear if the fund is a grant fund. The grant inception-to-date amounts are actual revenue and budget amounts over the life of the grant. The data may be more useful in analyzing grant revenue than the fiscal year data.

Option 3 Entry

An Option 3 revision is entered by completing the Fund Entry section and the Expense Acct Entry section as described in the Basics for Options 1, 2, and 3 section of this document. The Revenue Acct Entry section must be completed as well; the entry into the Revenue Acct Entry section functions the same as the entry into the Expense Acct Entry section.

After all data has been entered, the following should be verified.

- 1) Ensure that the 'Document Total' field = 0.00. This means the document is balanced. The system will not allow an unbalanced budget revision to be submitted.

- 2) Check any error and warning messages to ensure the budget revision is valid. See Appendix B for a list of warnings and their possible causes.
- 3) Use the Revenue Analysis section to verify that the current revenue budget will be exceeded by the amount of the budget revision. Add a comment or an attachment to justify the increase to the revenue budget if the revenue analysis does not support the increase.
- 4) Make note of the Budget Revision Transaction Number in the Create a New Budget Revision section in order to track the budget revision upon submission, or to complete the revision at a later time.

Option 4 Transfer Between FOPs

Anytime money is transferred between two different funds the Option 4 revision should be used. The Option 4 revision will posts both the budget revision and the Cash JV to Banner Finance upon approval. The Option 4 revision has different sections than Option 1, 2 and 3, but the data entry into Option 4 is similar.

The Option 4 revision is built upon the fact that there is a **Transfer-IN** FOP and a **Transfer-OUT** FOP. Both sides of the transfer are required to be input.

Transfer Entry

The Transfer Entry section is used in place of the Fund Entry section in the other Options. This requires two funds to be entered for the Option 4 revision. The transferring in FOP must be entered on the first line. The transferring out FOP should be entered into the second line.

Transfer-In Line

- **Fund Code:** Enter the fund code that money is being transferred into. The Fund Code Description will populate with the fund title when you tab forward.
- **ORGN Code:** The organization code will populate based on the default organization code for the fund. If no default exists, enter a valid organization code. If a default organization code is populated it may be changed by clearing the field and entering a valid organization code. The Orgn Code Description will populate with the orgn title after entry into the ORGN code field.

- **Program Code:** The program code will populate based on the default program code on the fund. This program code can only be changed if the default program code is 10, 35 or 40. To change the program code, clear the field and enter in the correct program code (10, 35 or 40).
- **Transfer Budget Acct Code:** Select the appropriate Transfer-In account code from the drop down list. For a General Funding Transfer choose the 8001 code. The 8095 code would be used for Internal Purchase Funding Transfers. A distinction between these types of transfers can be found in the document titled [Budget Basics Reference Guide](#).

Transfer-Out Line

The fields for the Transfer-Out line are the same as those on the Transfer-In line. The Fund, Orgn and Program code that money is being transferred out of must be entered on this line. The Transfer Budget Acct Code will pre-populate with the valid Transfer-Out Account code based on the Transfer-In code chosen on the Transfer-In line.

After completing the Transfer-Out line click the 'Next' radio button to continue to the Transfer-In Entry section of Option 4.

Since the Option 4 revision allows the use of a Revenue Code or a Fund Balance code, the Available Balance field will reflect the YTD Revenue received (as noted in Option 3), or the Available Fund Balance (as noted in Option 2).

After all data has been entered, the following should be verified.

- 1) Ensure that the 'Document Total' field = 0.00 in the Transfer Entry section. This means the document is balanced. The system will not allow you to submit an unbalanced budget revision.
- 2) Check any error and warning messages to ensure the budget revision is valid. See Appendix B for a list of warnings and their possible causes.
- 3) If the revenue budget is being increased, use the Revenue Analysis section to determine if the estimated revenue will exceed the current revenue budget. Add a comment or an attachment to justify the increase to the revenue budget if the revenue analysis does not support the increase.
- 4) If you budget Fund Balance in this option, enter a comment or add an attachment to justify the use of Fund Balance.
- 5) The Option 4 revision will generate the Accounting Services cash JV. If the cash JV should not be processed at the same time as the budget revision, an Installment Funding Transfer (IFT) form should be attached and a comment should be made alerting Accounting to this request.
- 6) Make note of the Budget Revision Transaction Number in the Create a New Budget Revision section in order to track the budget revision upon submission, or to complete the revision at a later time.

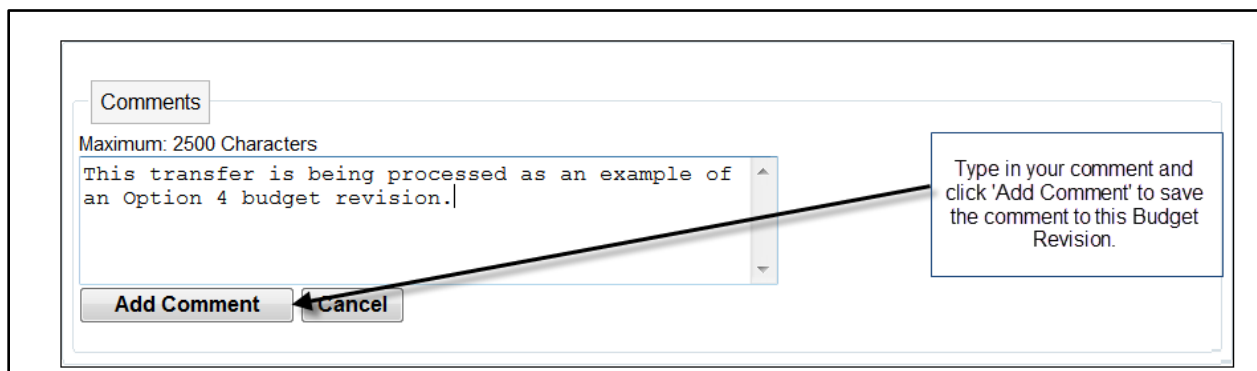

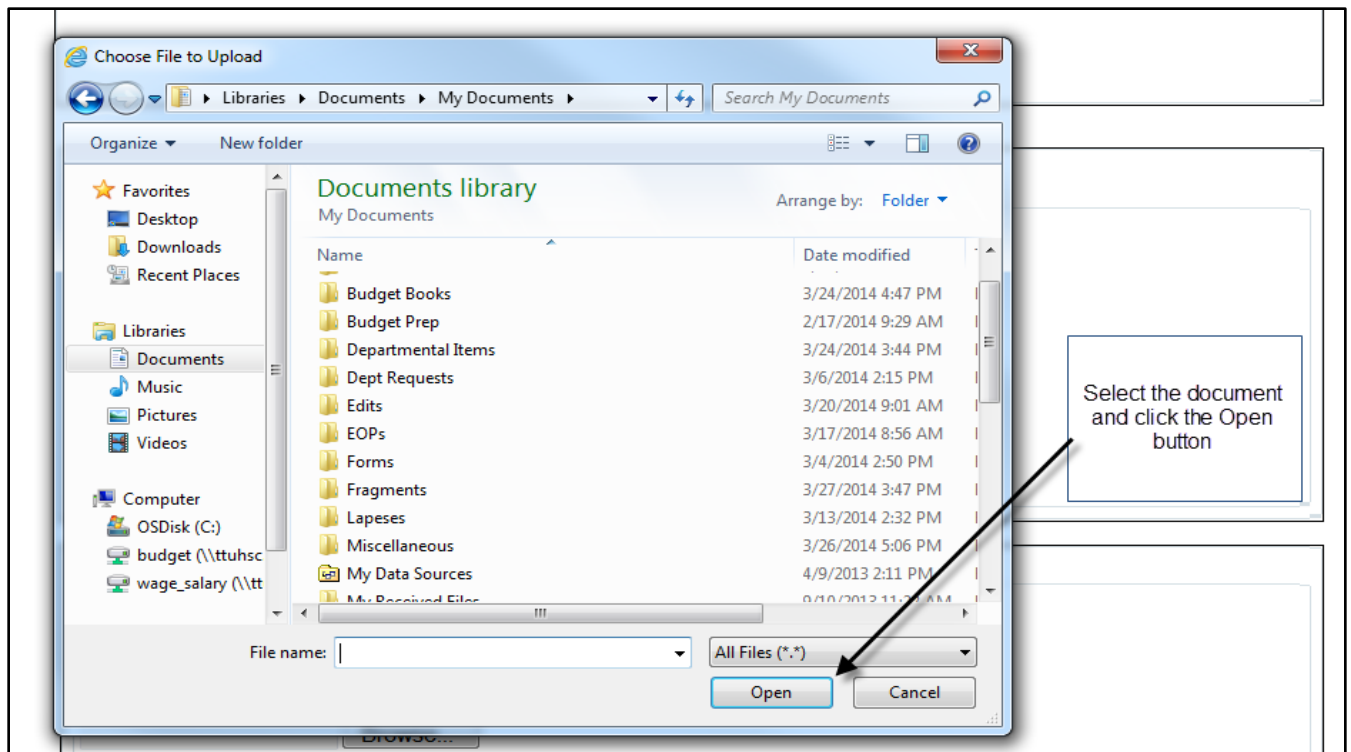

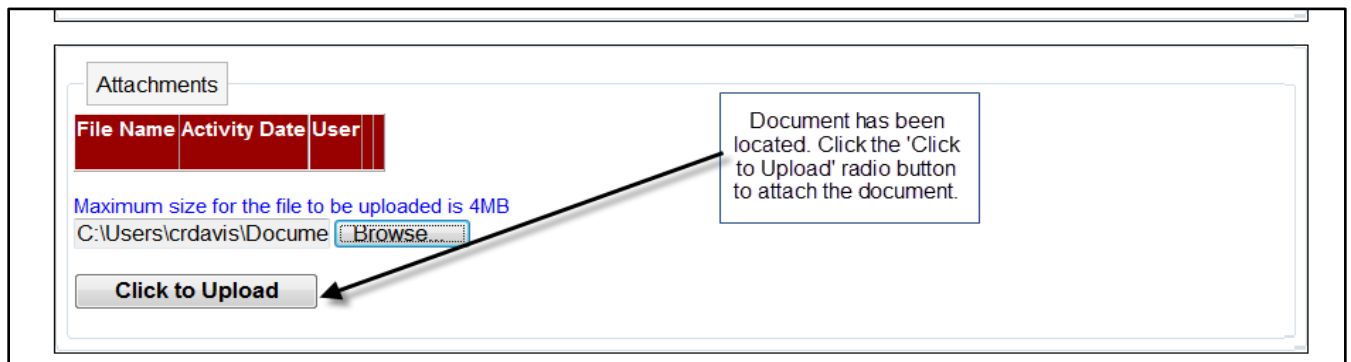

Informational Fields

- **Group Name:** The Budget Revision System approvals are based on approval groups. The approval group name describes the level of required approvals for the budget revision.
 - **Fund Approver**-The Fund Financial Manager listed in the Banner Finance system is the fund approver. The Additional Approvers for the fund manager are set by the fund manager in the TEAM application. These are the alternate approvers used in the TechBuy system. The Fund Approver is required on all Option 2, 3, and 4 revisions.
 - If the Fund Approver remains blank and does not populate, please contact the Budget Office.
 - **Campus level** – School of Medicine requires approval at the campus level for revisions increasing revenue or using fund balance in excess of \$24,999. The approver and additional approvers for this level are set by the Budget Office.
 - **Division level** - Each Institutional Division has an approver for revisions meeting certain criteria. The approver and additional approvers for this level are set by the Budget Office at the request of each division head. Revisions increasing revenue or using fund balance in an amount greater than \$24,999 will require division head approval.
 - **HSC Research Integrity Office (RIO)** – Individuals from Research Integrity will review and approve revisions in this group. Most revisions relating to a Clinical Trial will route to RIO.

- **HSC Office of Sponsored Programs** – The Office of Sponsored Programs will review most budget revisions relating to a Sponsored Project.
 - **HSC Accounting** – Accounting Services will review most restricted fund revisions, all Option 4 revisions and all revisions relating to endowment earnings.
 - **HSC Budget Office** – The Budget Office will review and approve all revisions with the exception of Option 1 revisions moving between expense codes beginning with a 7.
 - **Assistant Vice President Budget** – The AVP for Budget will review and approve revisions with an increase in revenue or use of fund balance greater than \$25,000 with the exception of federal and state grants.
 - **Approvals outside BRS** - Additional approvals may be required per the Budget Revision OP. These will be obtained by the Budget Office outside BRS.
- **Approver Name** - Name of the group approver.
 - **Additional Approvers** - People who can approve in place of the group approver. As state above the Fund Financial Manager has the ability to set alternate approvers in the TEAM application. The division level approver will contact the Budget Office to set alternate approvers. Other areas have identified alternate approvers within their offices.
 - **Group ID** - Used by BRS to identify the approver for each level.

Adding an Additional Approver

BRS will allow an additional approver to be added. The additional approver can be added either before or after the Fund Approver. These are the only places the additional approver can be added.

- If the budget revision requires no approvals, the revision is submitted directly to a holding table and will be processed in Banner Finance within 15 minutes. The originator will be notified when the revision is posted.
- If the revision requires approvals, the Budget Revision System sends the routing information to the Approval Tracking System (ATS). ATS will send an email notifying the approver that there is a document to approve.
- The approver has the ability to approve or reject the document. The approver may also add comments and attachments to the budget revision.
- The originator will be notified if the document is rejected.
- The originator will be notified when the document is approved by the final approver and is posted to the Banner Finance system.

Printing the Budget Revision

The 'Print' radio button can be used to print a hard copy of the budget revision. This button is located on the Create a New Revision screen and the Status screen.

Deleting a Budget Revision

The Budget Revision can be deleted by using the 'Delete' radio button located on the Create a Budget Revision page. The revision can be deleted at any time before submitting the revision for approval. Once the document has been submitted for approval it cannot be deleted unless the document is rejected back to the originator.

Finish/Delete an Incomplete Budget Revision

If a budget revision was not completed or is returned for correction, the Finish/Delete an Incomplete Budget Revision action should be used. This may be accessed by choosing the 'Create a Budget Revision' link on the left panel of the Budget Revision system.

Select the Finish/Delete an Incomplete Budget Revision from the drop down menu.

Required Search Fields

Data is not required in all fields for a search to begin. The following two fields are required.

- Chart Code: A chart code is required for any search. Choose from the following chart codes.

- **Fiscal Year:** The current fiscal year will default into the search field. This may be changed to another fiscal year if necessary.

Optional Search Fields

- **Orgn Code:** Use the orgn code to search for budget revisions on a particular organization code.
- **Trans Nbr:** Input the Budget Revision System transaction number to search for a single budget revision. This is the 'BR' number displayed on each budget revision.
- **Banner Document:** Input the Banner Finance document id from Cognos reports. This is the 'BA' prefix in Banner Finance.
- **Date Range:** Enter a begin and end date to search for budget revisions entered within a given time period.
- **Status:** Budget revisions have a status as they flow from origination to approved. To narrow down a search the status feature may be used. **In Process** – Revisions that have not been finished or revisions that have been returned for correction. **Submitted** – Revisions that have been submitted for approval and have not been approved at all levels. **Approved** – Documents that have been approved and posted to the Banner Finance system. **Rejected** – Revisions that have been rejected by an approver and are awaiting correction or deletion. **Expired** – Budget revisions that have not been approved within 30 days will expire and will need to be re-entered and submitted again.
- **Click the 'Apply Filter':** radio button to search based on the items entered.
- **Page Size:** This may be changed depending on how many items you would like to view per page.

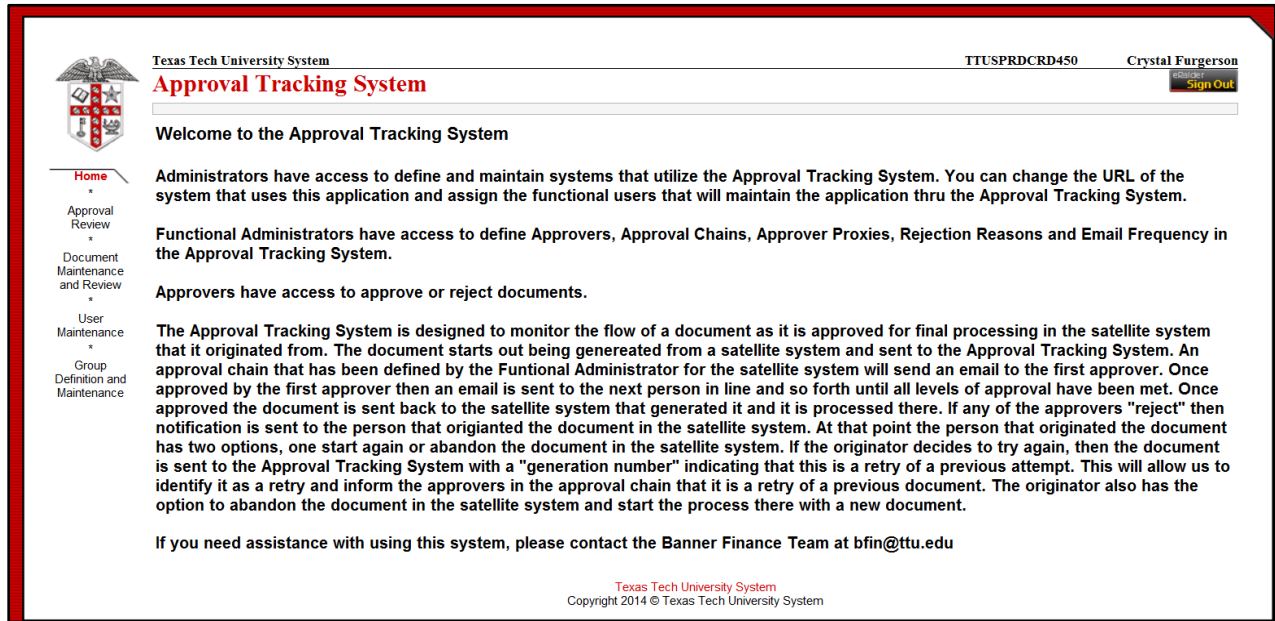

Functional Administrators have access to define Approvers, Approval Chains, Approver Proxies, Rejection Reasons and Email Frequency in the Approval Tracking System.

Approvers have access to approve or reject documents.

The Approval Tracking System is designed to monitor the flow of a document as it is approved for final processing in the satellite system that it originated from. The document starts out being generated from a satellite system and sent to the Approval Tracking System. An approval chain that has been defined by the Functional Administrator for the satellite system will send an email to the first approver. Once approved by the first approver then an email is sent to the next person in line and so forth until all levels of approval have been met. Once approved the document is sent back to the satellite system that generated it and it is processed there. If any of the approvers "reject" then notification is sent to the person that originated the document in the satellite system. At that point the person that originated the document has two options, one start again or abandon the document in the satellite system. If the originator decides to try again, then the document is sent to the Approval Tracking System with a "generation number" indicating that this is a retry of a previous attempt. This will allow us to identify it as a retry and inform the approvers in the approval chain that it is a retry of a previous document. The originator also has the option to abandon the document in the satellite system and start the process there with a new document.

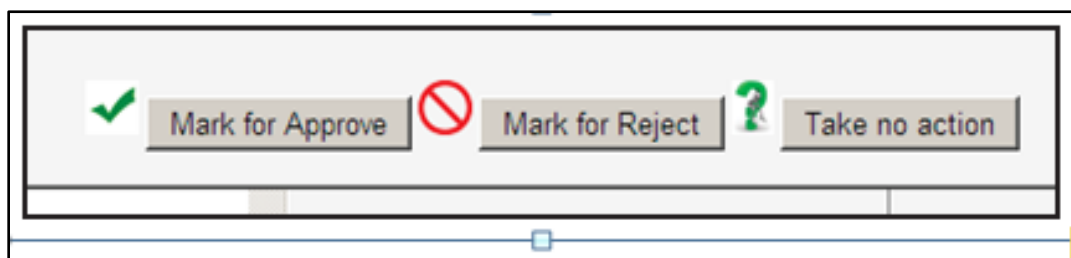

Approvers should review the entire document and pay special attention to the following items:

- **Warnings:** Warnings should be reviewed and questioned. Some warnings are information items only. Others may indicate an actual problem with the budget revision.
- **Comments:** Do the comments sufficiently justify the budget revision?
 - Option 2 (Budget of Fund Balance): Does the comment explain why fund balance is being budgeted? Is this for a one time use of funds?
 - Option 3 (Budget of Revenue): Does the comment justify the increase to the budget? Can this revenue be earned? A revenue analysis section is provided to help determine if revenue will be earned. Please see the Option 3 Budget of Revenue section for a detailed explanation of the revenue analysis.
 - Option 4 (Transfer between FOPs): If fund balance or revenue is being budgeted the same justification is required as in Options 2 and 3.
 - Approvers are able to add additional comments if necessary
- **Attachments:** Verify that any attachments offer supporting documentation to this budget revision.
 - Approvers are able to add additional attachments or delete an attachment if necessary.

Help Adding User

The 'Delete' radio button can be used to remove the added approver.

Setting Email Frequency

Emails are set to immediately notify an approver that a document is waiting for their approval. With the addition of multiple systems using ATS for routing and approvals an approver may prefer to have emails sent less frequently.

Click the User Maintenance link on the left side of ATS to access a screen that will allow changes to the email frequency from this system.

Click the drop down menu on the Select Frequency field to choose the preferred frequency. Then click the 'SET FREQUENCY' radial button to save this change.

Frequency Tips

The Budget Office recommends that the frequency be set to 'Immediate' or 'Once Daily at 4:00 pm'. This will ensure approvers are notified of documents to approve in a timely manner. Some documents may be time sensitive and other email options will create a delay in notification.

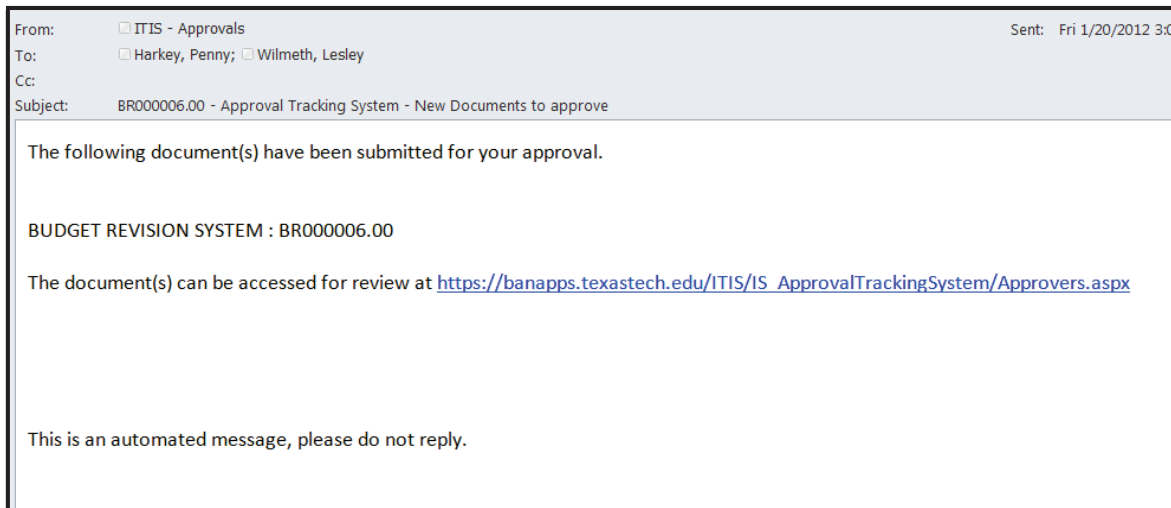
Several automated emails are generated from the Budget Revision System and the Approval Tracking System. This section will explain each email, the action required and an example of the email.

New Document to Approve

The following email will be sent to the approver and their proxies when a new budget revision is awaiting their approval. This email states 'New documents to approve' within the subject line.

Action Required

The approver should click on the link within the email to go into ATS. In ATS the budget revision should be reviewed and either approved or rejected.



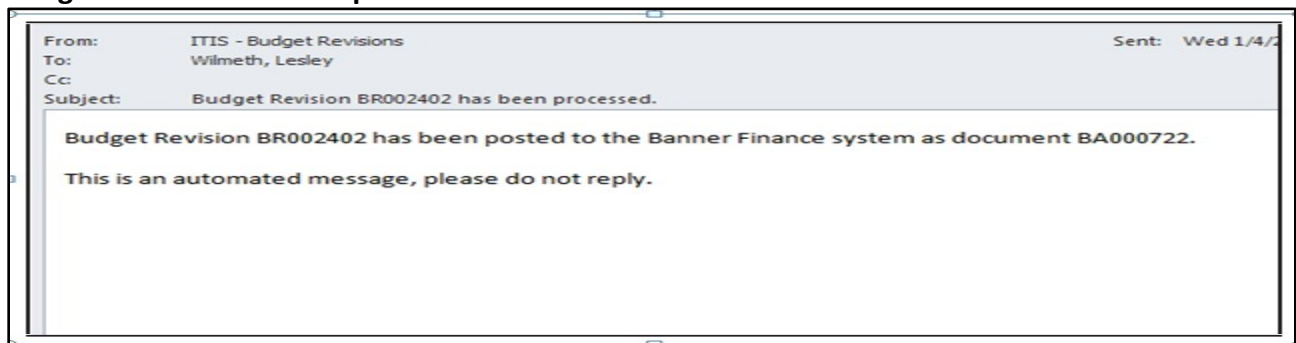
Document Approved

The following email will be sent to the budget revision originator when the budget revision has been approved at all levels and has posted to Banner Finance.

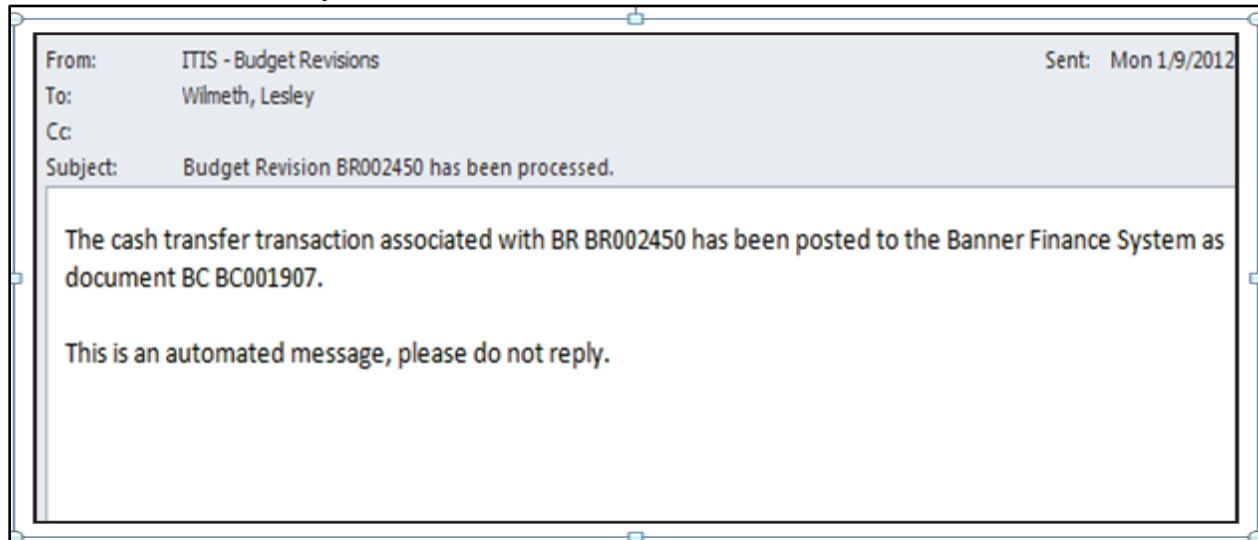

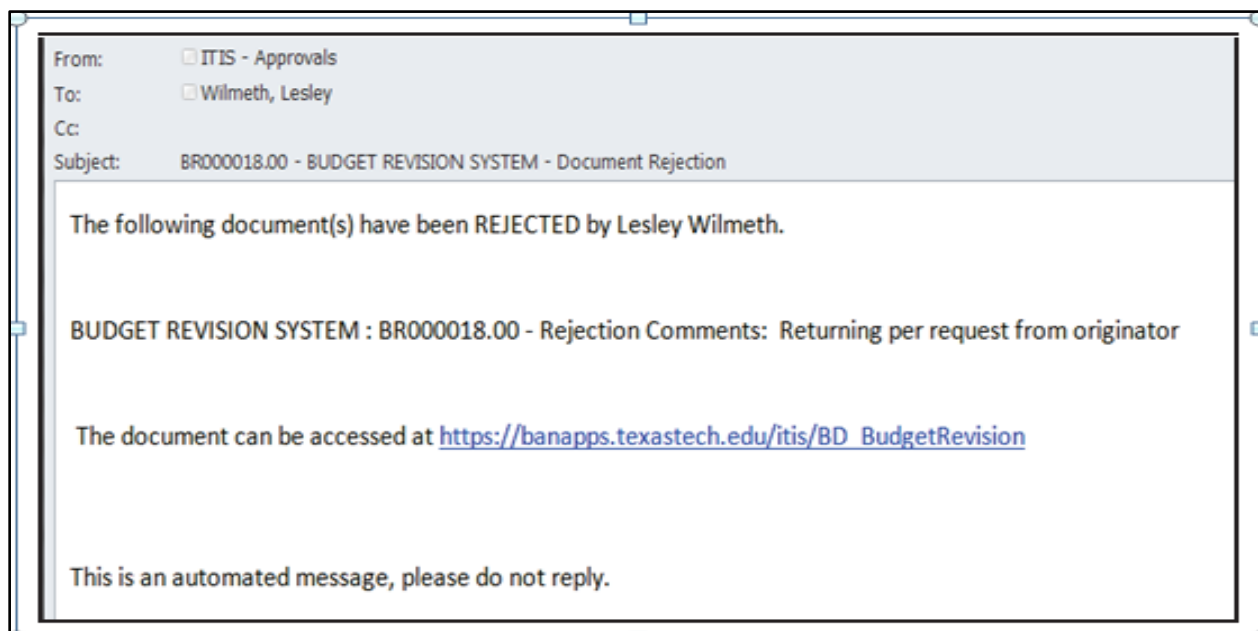


Document Rejected

If the document is being returned for correction, the system will send an email to the budget revision originator notifying them that there is a problem with the document.

Action Required

The originator should use the link in the email and log into BRS. The document should be edited or deleted by using the 'Finish or Delete an Incomplete Document' option.



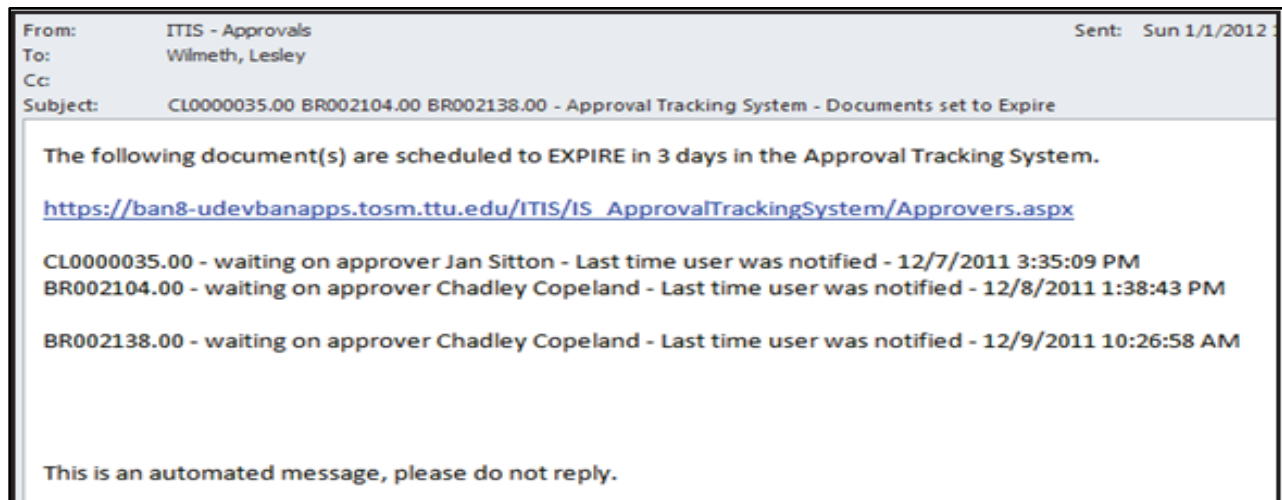
Expiring Document

The originator will receive an email notifying them that a document has not been approved in ATS and is set to expire. If an originator does not approve a document within 30 days the document will expire and will need to be resubmitted.

The originator will be notified of the expiration 4 days before the expiration date and again 1 day before the expiration date.

Action Required

The originator should contact the approver to either approve or reject the document.

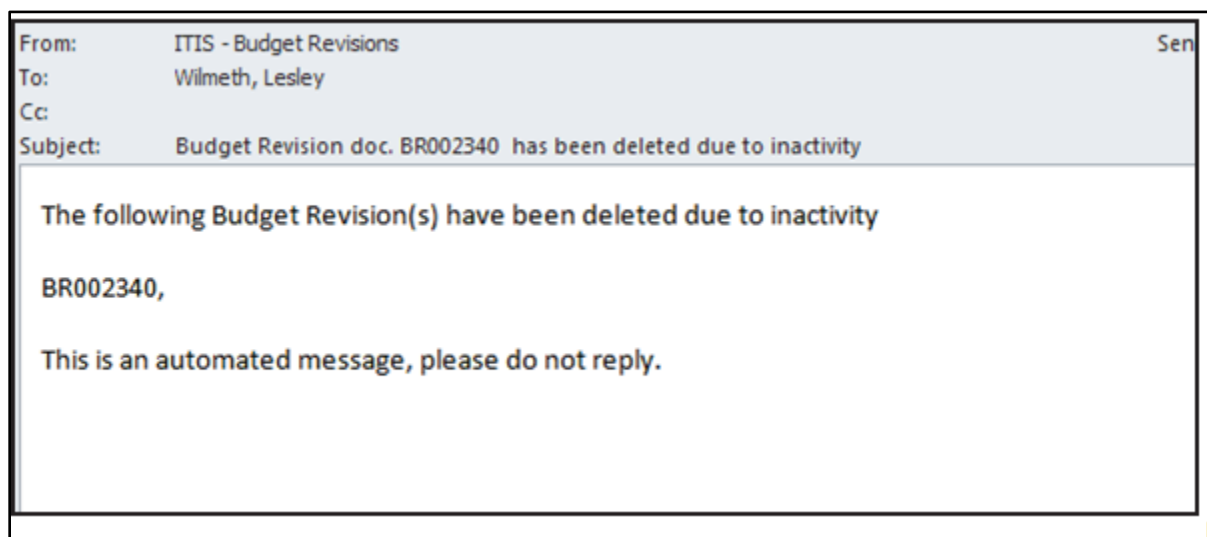


Revision Deleted

If a budget revision is never finished and submitted to approvals, or if the revision was rejected and not edited it will be deleted from the system 30 days after the last action occurred on the revision.

APPENDIX B: Errors and Warning

All errors and warnings are listed in alphabetical order to aid you in searching for the error or warning. The error or warning message is given first, then the reason why the error may have appeared and the action necessary to clear the error.

B

Budget revision is not balanced. Fund total for the IN must not equal zero.

Reason:

The document total field in the Transfer IN entry section is equal to zero.

Corrective Action:

Check the Document Total box in the Transfer IN entry section. This amount should NOT be zero. Enter the appropriate transfer in budget lines on the Option 4 revision.

Review the Transfer section of the “Budget Basics” document located at https://hscweb.ttuhsu.edu/budget/instructions_and_information.aspx for more information.

Budget revision is not balanced. Fund total for the OUT must not equal zero.

Reason:

The document total field in the Transfer Out entry section is equal to zero.

Corrective Action:

Check the Document Total box in the Transfer Out entry section. This amount should NOT be zero. Enter the appropriate transfer out budget lines on the Option 4 revision.

Review the Transfer section of the “Budget Basics” document located at https://hscweb.ttuhsu.edu/budget/instructions_and_information.aspx for more information.

Budget revision is not balanced. The document total must equal zero.

Reason:

The document total field is not zero.

Corrective Action:

Check the Document Total box in the Revenue Acct Entry section, Expense Acct Entry section or the Transfer Entry section. If the total does not equal 0.00, review the budget revision and make necessary corrections. On an Option 1 revision, pluses and minuses to expense codes must equal in total. On an Option 2 revision, the total change to revenue must equal the total change to the expense codes. On an Option 4 revision, the 'Transfers-In' must equal the 'Transfers-Out'.

E

Effective Date: The accounting period is closed.

Reason:

The validation date on the budget revision is for a closed accounting period in Banner Finance.

Corrective Action:

Contact the Budget Office if this error appears.

Expense Acct Entry: "xx" is an invalid program code

Reason

The program code entered is not valid.

Corrective Action

Review the program code. It should be a 2 digit code. A list of valid program codes can be found on the Finance Systems Management (FSM) website under the "Reference Material" link.

Expense Acct Entry: "xxxx" is an invalid expense account code

Reason:

The account code entered is not a valid Budget Account Code.

Corrective Action:

Please check the following:

- Ensure that you have not entered a revenue account code (account code beginning with a 5) in the Expense Acct Entry section.
- Also verify that you have entered a 4 digit Budget Account Code. The 6 digit account codes used for actual expenditures are not allowable on a budget revision.
- Use the Cognos report *Budget>Budget Financial Reports>RPT_ACCT_001 – Budget and Data Entry Account Codes* to identify the appropriate Budget Account Code.

Expense Acct Entry: "xxxx" - Transfer in budgets may not exceed zero. The budget is being increased by an amount greater than the Current Budget Amount.

Reason:

The 8001 or 8095 transfer in Budget Account Codes carry a negative balance. The balance on these codes cannot be greater than 0.00.

Corrective Action:

Review the Current Budget Amount on the 8001 or 8095 entry line. Compare this to the amount you entered to be adjusted. Make any necessary corrections to the amount to ensure the budget adjustment does not cause the Current Budget Amount to be greater than zero.

Expense Acct Entry: "xxxxxx" is an invalid ORGN code

Reason:

The organization code entered is not a valid orgn code, or the organization code is not the 6 digit data enterable orgn code.

Corrective Action:

Review the organization code and make sure it was entered correctly. If you are unsure of the organization code, you can run the Cognos report *Budget>Budget Financial Reports> RPT_ORGN_001 – Organization Listing*.

Expense Acct Entry: "xxxxxx-xxxxxx-xxxxxx-xx" The budget is being reduced by an amount that is greater than the Budget Available Balance.

Reason:

A reduction to a FOAP line is limited to the Budget Available Balance (BAVL balance) on that FOAP line. This error occurs if you are trying to reduce the budget on a line by more than what is available.

Corrective Action:

Review the Budget Available Balance on the FOAP line shown in the error panel. Ensure that you are not trying to move more than is available for this FOAP line. Run the Cognos report *Budget>Budget Financial Report> RPT_BAVL_005 – Available Balance by Organization (BAVL)* to see more information about the Budget Available Balance.

Expense Acct Entry: Account Code "xxxx" may not be used on fund "xxxxxx"

Reason:

The account code entered is not allowable for the fund code entered. Example: 7035 (Food and Entertainment) is not allowed on E&G funds (funds beginning with 10).

Corrective Action:

Verify that you have entered the correct fund and the correct account code. Edit the budget line if corrections should be made.

Expense Acct Entry: Account Code "xxxx" on fund "xxxxxx" must be approved by the Budget Office

Reason:

This warning exists to alert the originator that a particular account code may not be allowable for the fund code entered. The use of this account code and fund will need approval by the Budget Office.

Corrective Action:

Ensure that the correct fund and account code have been entered. Enter a comment explaining why this account code should be used.

Expense Acct Entry: Account Code "xxxx" - the budget is being reduced by an amount that is greater than the Current Budget Amount

Reason

The amount entered on the line exceeds the Current Budget for this line.

Example: The Current Budget is \$100. (\$150) is entered as the amount to move to another code. You are trying to move \$50 more than is budgeted for this account code.

Corrective Action:

Check the Current Budget Amount on the line with the error. Correct the amount to be moved to be less than or equal to the current budget amount.

Expense Acct Entry: Amount may not exceed 9,999,999,999

Reason:

An amount entered is > 9,999,999,999. The system only allows up to 10 digits to the left of the decimal.

Corrective Action:

Correct the amount entered to be below 10,000,000,000.

Expense Acct Entry: ORGN "xxxxxx" may not be used with fund "xxxxxx".

Reason:

Each fund code belongs to a department. If the organization code is not within the department listed for the fund this warning message will appear.

Corrective Action:

Review the fund and orgn code entered to ensure they are correct. The Cognos report *HSC Finance>Chart of Accounts>Fund and Organization Combinations* can be run to help determine which orgn codes are valid for a particular fund.

Expense Acct Entry: Select plus or minus

Reason:

The user did not select plus or minus next to the dollar amount.

Corrective Action:

Use the drop down box under the "Plus Minus" column and select a sign for the amount.

Expense Acct Entry: The default program code "xx" must be used with fund "xxxxxx"

Reason:

Default program codes exist on each fund code. The default program must be used for this particular fund code.

Corrective Action:

The default program code is listed in the Revenue, Expense and Transfer entry sections of the system. Review this default and correct the program code to match the default. If you feel that the default program code is incorrect, please contact the Budget Office.

Expense Acct Entry: The default program code is “xx”. Only program codes 10, 35 or 40 may be used with fund “xxxxxx”.

Reason:

The default program code for the fund is 10, 35 or 40. Only these 3 program codes can be used with the fund entered.

Corrective action:

The default program code is listed in the Revenue, Expense and Transfer entry sections of the system. Review this default and correct the program code to 10, 35 or 40. If you feel that the default program code is incorrect, please contact the Budget Office.

F

Fiscal Year: The fiscal year is closed for Budget Revision processing.

Reason:

Fiscal year entered into the system is closed. Budget Revisions cannot be processed against a closed fiscal year.

Corrective Action:

Verify that the fiscal year entered is accurate. If the fiscal year is accurate and the message continues, contact the Budget Office.

Fund Balance Information: The fund balance amount exceeds the Available Fund Balance

Reason:

The fund balance being budgeted exceeds the Fund Balance that is available to be budgeted.

Corrective Action:

Review the Cognos report *Budget>Budget Financial Reports> RPT_GENL_001 – Prior Year Fund Balance Available to Carry-Forward* for the amount of fund balance that is available to be budgeted. The fund balance calculation is as follows:

Prior Year Ending Fund Balance – Prior Year Encumbrances – Current Fund Balance
Budget

Fund Entry: Budget Revisions are not allowed on Fund “xxxxxx”

Reason:

Certain funds do not have any budget associated with them. Others may not allow budget revisions to be processed through the Budget Revision System. These include Loan funds, certain Endowment funds, and Foundation funds.

Corrective Action:

Verify that the fund number entered is accurate. If the fund number is correct and you feel that a revision needs to be processed for this fund, contact the Budget Office.

Fund Entry: Budget Revisions are not allowed on Fund “xxxxxx”. This fund is budgeted in the nightly fund balance process.

Reason:

Fund Entry: Fund “xxxxxx” is either invalid or not active as of the transaction effective date

Reason:

- The fund has been terminated.
- The fund is not active yet (example: Budget revision validation date = 8/31/2011; fund effective date = 9/1/2011)
- The fund has been entered incorrectly.

Corrective Action:

Verify that the fund entered is correct. If the fund is correct and is a new fund, look at the effective date of the fund and compare it to the BRS validation date. If the new fund effective date is after today’s date you will need to wait until the new fund effective date to enter this revision.

Fund Entry: The transaction effective date is greater than the grant end date

Reason:

The grant has already ended.

Corrective Action:

This is a warning message only. It will alert all approvers that a revision is being requested on a grant that has ended.

Reason

The program code entered is not valid.

Corrective Action

Review the program code. It should be a 2 digit code. A list of valid program codes can be found on the Finance Systems Management (FSM) website under the “Reference Material” link.

Revenue Acct Entry: "xxxx" is an invalid revenue account code*Reason:*

The account code entered is not a valid Budget Account Code.

Corrective Action:

Please check the following:

- Also verify that you have entered a 4 digit Budget Account Code. The 6 digit account codes used for actual expenditures are not allowable on a budget revision.

Corrective Action:

Review the organization code and make sure it was entered correctly. If you are unsure of the organization code, you can run the Cognos report *Budget>Budget Financial Reports> RPT_ORGN_001 – Organization Listing*.

Revenue Acct Entry: Account Code 5099 (Fund Balance) is only allowed on an Option 2 Budget Revision*Reason:*

Corrective Action:

Reason:

Certain funds do not have any budget associated with them. Others may not allow budget revisions to be processed through the Budget Revision System. These include Loan fund, certain Endowment funds and Foundation funds.

Corrective Action:

Verify that the fund number entered is accurate. If the fund number is correct and you feel that a revision needs to be processed for this fund, contact the Budget Office.

Transfer Entry: Fund “xxxxxx” is either invalid or not active as of the transaction effective date

Reason:

- The fund has been terminated.
- The fund is not active yet (example: Budget revision validation date = 8/31/2011; fund effective date = 9/1/2011)
- The fund has been entered incorrectly.

Corrective Action:

Verify that the fund entered is correct. If the fund is correct and is a new fund, look at the effective date of the fund and compare it to the BRS validation date.

Transfer Entry: Fund codes for transfer-in and transfer-out cannot be the same for Option 4. Please use Option 1.

Reason

The fund entered for the transfer-in and the transfer-out are the same. We do not use transfer codes to move money within the same fund.

Corrective Action:

If you are trying to move money within the same fund use the Option 1 revision. Option 1 can be used to move between organization and program codes within the same fund.

Transfer Entry: ORGN “xxxxxx” may not be used with fund “xxxxxx”.

Reason:

Each fund code belongs to a department. If the organization code is not within the department listed for the fund this warning message will appear.

Corrective Action:

Review the fund and orgn code entered to ensure they are correct. The Cognos report *HSC Finance>Chart of Accounts>Fund and Organization Combinations* can be run to help determine which orgn codes are valid for a particular fund.

Transfer Entry: The default program code “xx” must be used with fund “xxxxxx”

Reason:

Default program codes exist on each fund code. The default program must be used for this particular fund code.

Corrective Action:

The default program code is listed in the Revenue, Expense and Transfer entry sections of the system. Review this default and correct the program code to match the default. If you feel that the default program code is incorrect, please contact the Budget Office.

Transfer Entry: The default program code is “xx”. Only program codes 10, 35 or 40 may be used with fund “xxxxxx”.

Reason:

The default program code for the fund is 10, 35 or 40. Only these 3 program codes can be used with the fund entered.

Corrective action:

The default program code is listed in the Revenue, Expense, and Transfer entry sections of the system. Review this default and correct the program code to 10, 35 or 40. If you feel that the default program code is incorrect, please contact the Budget Office.

Transfer Entry: The transaction effective date is greater than the grant end date

Reason:

The grant has already ended.

Corrective Action:

This is a warning message only. It will alert all approvers that a revision is being requested on a grant that has ended.

Transfer Entry: Transfers are not allowed between fund “xxxxxx” and fund “xxxxxx”

Reason:

The two funds entered are not allowed to transfer between each other. For example transfers are not allowed into an E&G state appropriated fund from an MPIP fund.

Corrective Action:

Review the funds entered into the revision and Review the Transfer section of the “Budget Basics” document located at https://hscweb.ttuhsu.edu/budget/instructions_and_information.aspx for more information on transfers between different fund types.

Transfer Entry: Transfers between fund “xxxxxx” and fund “xxxxxx” must be approved by the Budget Office.

Reason:

This warning exists for E&G state appropriated funds to alert the user that different E&G funding sources are being used in this transfer. Transfers between certain E&G funds are not allowed and must be reviewed by the Budget Office.

Corrective Action:

Verify that the funds entered are correct. Contact the Budget Office to determine if this transfer is appropriate. Make a comment as to why this transfer is being requested.

Transfer-In Entry: "xx" is an invalid program code

Reason

The program code entered is not valid.

Corrective Action

Review the program code. It should be a 2 digit code. A list of valid program codes can be found on the Finance Systems Management (FSM) website under the "Reference Material" link.

Transfer-In Entry: "xxxx" is an invalid account code

Reason:

The account code entered is not a valid Budget Account Code.

Corrective Action:

Please check the following:

- Verify that you have entered a 4 digit Budget Account Code. The 6 digit account codes used for actual expenditures are not allowable on a budget revision.
- Use the Cognos report *Budget>Budget Financial Reports>RPT_ACCT_001 – Budget and Data Entry Account Codes* to identify the appropriate Budget Account Code.

Transfer-In Entry: "xxxx" - Transfer-in budgets may not exceed zero. The budget is being increased by an amount greater than the Current Budget Amount.

Reason:

The 8001 or 8095 transfer in Budget Account Codes carry a negative balance. The balance on these codes cannot be greater than 0.00.

Corrective Action:

Review the Current Budget Amount on the 8001 or 8095 entry line. Compare this to the amount you entered to be adjusted. Make any necessary corrections to the amount to ensure the budget adjustment does not cause the Current Budget Amount to be greater than zero.

Transfer-In Entry: "xxxxxx" is an invalid ORGN code

Reason:

The organization code entered is not a valid orgn code, or the organization code is not the 6 digit data enterable orgn code.

Corrective Action:

Review the organization code and make sure it was entered correctly. If you are unsure of the organization code, you can run the Cognos report *Budget>Budget Financial Reports>RPT_ORGN_001 – Organization Listing*.

Transfer-In Entry: "xxxxxx-xxxxxx-xxxxxx-xx" The budget is being reduced by an amount that is greater than the Budget Available Balance.

Reason:

A reduction to a FOAP line is limited to the Budget Available Balance (BAVL balance) on that FOAP line. This error occurs if you are trying to reduce the budget on a line by more than what is available.

Corrective Action:

Review the Budget Available Balance on the FOAP line shown in the error panel. Ensure that you are not trying to move more than is available for this FOAP line. Run the Cognos report *Budget>Budget Financial Report>RPT_BAVL_005 – Available Balance by Organization (BAVL)* to see more information about the Budget Available Balance.

Transfer-In Entry: Account Code “xxxx” may not be used on fund “xxxxxx”

Reason:

The account code entered is not allowable for the fund code entered. Example: 7035 (Food and Entertainment) is not allowed on E&G funds (funds beginning with 10).

Corrective Action:

Verify that you have entered the correct fund and the correct account code. Edit the budget line if corrections should be made

Transfer-In Entry: Account Code “xxxx” on fund “xxxxxx” must be approved by the Budget Office

Reason:

This warning exists to alert the originator that a particular account code may not be allowable for the fund code entered. The use of this account code and fund will need approval by the Budget Office.

Corrective Action:

Ensure that the correct fund and account code have been entered. Enter a comment explaining why this account code should be used.

Transfer-In Entry: Account Code “xxxx” - the budget is being reduced by an amount that is greater than the Current Budget Amount

Reason

The amount entered on the line exceeds the Current Budget for this line.

- Example: The Current Budget is \$100. (\$150) is entered as the amount to move to another code. You are trying to move \$50 more than is budgeted for this account code.

Corrective Action:

Check the Current Budget Amount on the line with the error. Correct the amount to be moved to be less than or equal to the current budget amount.

Transfer-In Entry: Amount may not exceed 9,999,999,999

Reason:

An amount entered is > 9,999,999,999. The system only allows up to 10 digits to the left of the decimal.

Corrective Action:

Correct the amount entered to be below 10,000,000,000.

Transfer-In Entry: ORGN “xxxxxx” may not be used with fund “xxxxxx”.

Reason:

Each fund code belongs to a department. If the organization code is not within the department listed for the fund this warning message will appear.

Corrective Action:

Review the fund and orgn code entered to ensure they are correct. The Cognos report *HSC Finance>Chart of Accounts>Fund and Organization Combinations* can be run to help determine which orgn codes are valid for a particular fund.

Transfer-In Entry: Select plus or minus

Reason:

The user did not select plus or minus next to the dollar amount.

Corrective Action:

Use the drop down box under the “Plus Minus” column and select a sign for the amount.

Transfer-In Entry: The default program code “xx” must be used with fund “xxxxxx”

Reason:

Default program codes exist on each fund code. The default program must be used for this particular fund code.

Corrective Action:

The default program code is listed in the Revenue, Expense and Transfer entry sections of the system. Review this default and correct the program code to match the default. If you feel that the default program code is incorrect, please contact the Budget Office.

Transfer-In Entry: The default program code is “xx”. Only program codes 10, 35 or 40 may be used with fund “xxxxxx”.

Reason:

The default program code for the fund is 10, 35 or 40. Only these 3 program codes can be used with the fund entered.

Corrective action:

The default program code is listed in the Revenue, Expense and Transfer entry sections of the system. Review this default and correct the program code 10, 35 or 40. If you feel that the default program code is incorrect, please contact the Budget Office.

Transfer-In Entry: The fund balance amount exceeds the Available Fund Balance

Reason:

The fund balance being budgeted exceeds the Fund Balance that is available to be budgeted.

Corrective Action:

Review the Cognos report *Budget>Budget Financial Reports: RPT_GENL_001 – Prior Year Fund Balance Available to Carry-Forward* for the amount of fund balance that is available to be budgeted. The fund balance calculation is as follows:

Transfer-In Entry: The YTD revenue for fund “xxxxxx” is less than the current revenue budget for the fund.

Reason:

The fund has not earned the revenue that is already budgeted.

Corrective Action:

Provide a comment explaining how the increase to the revenue budget will be realized and justifying the need for the increase.

Transfer-Out Entry: “xx” is an invalid program code

Reason

The program code entered is not valid.

Corrective Action

Review the program code. It should be a 2 digit code. A list of valid program codes can be found on the Finance Systems Management (FSM) website under the “Reference Material” link.

Transfer-Out Entry: “xxxx” is an invalid account code

Reason:

The account code entered is not a valid Budget Account Code.

Corrective Action:

Please check the following:

- Verify that you have entered a 4 digit Budget Account Code. The 6 digit account codes used for actual expenditures are not allowable on a budget revision.
- Use the Cognos report *Budget>Budget Financial Reports>RPT_ACCT_001 – Budget and Data Entry Account Codes* to identify the appropriate Budget Account Code.

Transfer-Out Entry: "xxxxxx" is an invalid ORGN code

Reason:

The organization code entered is not a valid orgn code, or the organization code is not the 6 digit data enterable orgn code.

Corrective Action:

Review the organization code and make sure it was entered correctly. If you are unsure of the organization code, you can run the Cognos report *Budget>Budget Financial Reports>RPT_ORGN_001 – Organization Listing*.

Transfer-Out Entry: "xxxxxx-xxxxxx-xxxxxx-xx" The budget is being reduced by an amount that is greater than the Budget Available Balance.

Reason:

A reduction to a FOAP line is limited to the Budget Available Balance (BAVL balance) on that FOAP line. This error occurs if you are trying to reduce the budget on a line by more than what is available.

Corrective Action:

Review the Budget Available Balance on the FOAP line shown in the error panel. Ensure that you are not trying to move more than is available for this FOAP line. Run the Cognos report *Budget>Budget Financial Report>RPT_BAVL_005 – Available Balance by Organization (BAVL)* to see more information about the Budget Available Balance.

Transfer-Out Entry: Account Code “xxxx” may not be used on fund “xxxxxx”

Reason:

The account code entered is not allowable for the fund code entered. Example: 7035 (Food and Entertainment) is not allowed on E&G funds (funds beginning with 10).

Corrective Action:

Verify that you have entered the correct fund and the correct account code. Edit the budget line if corrections should be made.

Transfer-Out Entry: Account Code “xxxx” on fund “xxxxxx” must be approved by the Budget Office

Reason:

This warning exists to alert the originator that a particular account code may not be allowable for the fund code entered. The use of this account code and fund will need approval by the Budget Office.

Corrective Action:

Ensure that the correct fund and account code have been entered. Enter a comment explaining why this account code should be used.

Transfer-Out Entry: Account Code "xxxx" - the budget is being reduced by an amount that is greater than the Current Budget Amount

Reason

The amount entered on the line exceeds the Current Budget for this line.
Example: The Current Budget is \$100. (\$150) is entered as the amount to move to another code. You are trying to move \$50 more than is budgeted for this account code.

Corrective Action:

Check the Current Budget Amount on the line with the error. Correct the amount to be moved to be less than or equal to the current budget amount.

Transfer-Out Entry: Amount may not exceed 9,999,999,999

Reason:

An amount entered is > 9,999,999,999. The system only allows up to 10 digits to the left of the decimal.

Corrective Action:

Correct the amount entered to be below 10,000,000,000.

Transfer-Out Entry: ORGN “xxxxxx” may not be used with fund “xxxxxx”.

Reason:

Each fund code belongs to a department. If the organization code is not within the department listed for the fund this warning message will appear.

Corrective Action:

Review the fund and orgn code entered to ensure they are correct. The Cognos report *HSC Finance>Chart of Accounts>Fund and Organization Combinations* can be run to help determine which orgn codes are valid for a particular fund.

Transfer-Out Entry: Select plus or minus

Reason:

The user did not select plus or minus next to the dollar amount.

Corrective Action:

Use the drop down box under the “Plus Minus” column and select a sign for the amount.

Review the Cognos report *Budget>Budget Financial Reports: RPT_GENL_001 – Prior Year Fund Balance Available to Carry-Forward* for the amount of fund balance that is available to be budgeted. The fund balance calculation is as follows:

Prior Year Ending Fund Balance – Prior Year Encumbrances – Current Fund Balance Budget

Transfer-Out Entry: The YTD revenue for fund “xxxxxx” is less than the current revenue budget for the fund.

Reason:

The fund has not earned the revenue that is already budgeted.

Corrective Action:

Provide a comment explaining how the increase to the revenue budget will be realized and justifying the need for the increase.
