After receiving approval from the Texas Tech University System Board of Regents, Texas Tech University Health Sciences Center submitted a request to exceed the Annual FTE Cap to the Legislative Budget Board and the Governor's Office of Budget, Planning and Policy. The request to exceed was from 1,834.7 FTE's to 1,934.7 FTE's. The FY 2014 four quarter average FTE's for the institution is 1,892.9 which below the requested level.
